TO APPLY TO THE EMT OR PARAMEDICINE (PMED) PROGRAM:

APPLY AT L&C:

 Submit an application. Admission applications may be submitted to the College in person, by mail, or via the College website (https://www.lc.edu/).

SUBMIT TRANSCRIPTS:

- Submit an official high school transcript showing proof of graduation, or GED® scores (recognized by a state-accredited provider) which qualify as a high school equivalency certificate within any of the fifty states to dklong@lc.edu
- Submit official transcripts from all post-secondary educational institutions attended to dklong@lc.edu

TAKE PLACEMENT TEST:

- If you graduated within the last four years, we can use your high school transcript ACT/SAT scores.
- An ACT score of 17-18 or above, SAT scores of 22-25 are required for the classes.
- Students wishing to enter the EMS Education classes and are not using ACT/SAT must score at or above on Next Gen Accuplacer:
 - o math 1 (260), math 2 (225)
 - o reading (250+) and writing (227) portions of the test, or
 - o Qualify for ENGL-131 or ENGL-137
- GPA of 2.0 or higher.

MEET WITH PROGRAM DIRECTOR:

PROGRAM ELIGIBILITY REQUIREMENTS:

EMT Classes:

- High school diploma or GED
- Valid driver's license
- Those pursuing professional EMT certification must be at least 18 years of age.
 - Individuals may enroll in class prior to their 18th birthday with the understanding that they will not be able to test for certification until age requirements are met.
- Current Basic Life Support (BLS) CPR card (preferably from the American Heart Association or BLS training course for Healthcare Providers and Professional Rescuers from American Safety & Health Institute (ASHI)) prior to class or obtained within the first two weeks of class. No other card will be accepted by the program)
- Enroll in MYLC, New Student Orientation (new college students only)
- Meet all the requirements as stated in the L&C
 Admission procedures above*

Paramedicine Classes:

- NREMT Certification or State of Illinois EMT license obtained by 1st day of PMED 131.
- High school diploma or GED
- Valid driver's license
- Provide a copy of your current Basic Life Support for Healthcare Providers (CPR) card from the American Heart Association (AHA) or BLS training course for Healthcare Providers and Professional Rescuers from American Safety & Health Institute (ASHI). No other card will be accepted by the certifying agency.
- Meet all the requirements as stated in the L&C
 Admission procedures above*
- Completed the pre- paramedicine entrance exam(testing in June yearly.
- BIOL 132- Human Biology or equivalent anatomy & physiology class approved by the program director with a grade of C or better.
